Deadline for submission: December 25, 2010.

We will notify the contributors of accepted papers by January 15, 2011.
All accepted papers will be placed at the conference web-site by February 1, 2011.

Date of conference – February 2-February 4, 2011.

The conference discussion forum will be with participation of representatives of central banks, Fed Reserve Banks of the USA, Association of British Bankers, Bank of Canada etc. Besides, researchers from more than 30 countries of the world are expected to participate. We expect to see more than 100 participants.
